<p><b>Instructions:</b></p> <p>If you are interested in serving as a visiting judge under special assignment appointed by the State Court Administrative Office (SCAO) and if you serve as a director, officer, manager, advisor, or employee of a business, you must take a leave of absence from that position, receive no compensation from that business, and be disqualified from hearing any matter related to the interests of that business during the period of judicial assignment. In addition, you must disqualify yourself from hearing any cases involving parties from previous matters in which you have acted as mediator.</p> <p>SCAO Judicial Assignment Procedures, Section (I)(M)(7) states, "no former judge who engages in the practice of law, including 'Of Counsel,' will be assigned to act as a judge by the State Court Administrative Office, unless a written waiver is granted by the State Court Administrator."</p> <p><b>Certification:</b> I certify that I am a resident of Michigan and I am not now practicing law or employed in an active capacity by a law firm nor am I serving in another branch of government. I understand that I may not be engaged in the practice of law or serve in another branch of government if I accept assignments as a judge. If I begin the practice of law or serve in another branch of government, I will notify the SCAO and will not accept any further assignments as a judge. I am an active member of the State Bar of Michigan. I understand that I may be required, under Canon 6C of the Michigan Code of Judicial Conduct, to file a financial report with the SCAO.</p>
