

Show Cause Docket

- Run daily date-generated report and review for validity and accuracy (20% late fee report)
- Check for payment plan (failure to pay or appear)
- Schedule to appear (show cause)
- Failure to appear results in bench warrant
- Appearance allows to resolve issues and provide for payment

Show Cause Docket, cont.

- Person appears at magistrate clerk's window
- Indicates willingness to make payments
- Clerk arranges installment plan and creates a payment order
- Refers more difficult matters to magistrate and/or district judge
