40-Hour General Civil Mediator Training:

This 40-hour State Court Administrative Office (SCAO) approved training is designed to teach participants the skills necessary to act as mediators in facilitating the resolution of general civil disputes. Participants will receive a detailed mediation manual and a jump-drive containing reproducible mediation forms.

- **Winter Dates:** Fridays, January 24, 31, February 7, 14, 21, 2014 from 8:30am – 5:00pm
