



# 16-Hour Advanced Mediation Training

## Elder Mediation

- **Focus:** Adult Guardianship and Family Caregiver Mediation.
- **Content Includes:** The mediator's responsibility toward inclusion of the older person's voice, multi-party mediation techniques, and pre-mediation preparation.
- **Outcome:** Mediators will learn the differences between other types of mediation and Elder Mediation and be prepared to organize and perform these kinds of mediations. Non-mediators will get an introduction to Elder Mediation.
- **Pre-Requisite:** Basic mediation training or senior services.





