

## REPORTING CIRCUIT COURT FELONY CONVICTIONS TO DEPARTMENT OF STATE

With the exceptions noted, every offense is reported at time of plea or finding of guilt using the plea date in the adjudication field on the abstract. For convictions reported only at sentencing, Felon Auto Used (1430 & 1440) and Drug Crimes (1140 & 9200), use the sentencing date in the adjudication field on the abstract.
