

CIRCUIT COURT FELONY CONVICTIONS

With the following exceptions, every offense is reported at time of plea or finding of guilt, etc. using the plea date in the adjudicated field on the abstract.
Convictions reported at sentencing: Felony Auto Used (1430 & 1440), and Drug Crimes (1140 & 9200). When imposing at time of sentencing, use the sentencing date in the adjudicated field on the abstract.
