Central Name Index

The central name index is used to locate a particular name that may have been entered on a JIS system on your AS400.

Accessing the CNI Screen:

From the Next Tran Line, enter CNI in the Next Tran field and then press <Enter>. The system will display the central name index screen.

CENTRAL NAME INDEX

The Central Name Index contains the names of persons associated with cases that have been entered on the computer.

To locate a particular name, type in the person's LAST NAME in the space below. Then press the ENTER key.

A list of names will be displayed beginning with the name that most closely matches the one you selected.






There are two options that can be taken from this screen.




