  - c. I have a right to a preliminary examination where it must be shown that there is probable cause to believe that a crime was committed and probable cause to believe that I committed the crime.
3. I voluntarily waive my right to a preliminary examination and understand that I will be tried as an adult in the family division of the circuit court on the crime(s) charged.
