# Judicial Information Systems

## Clerk Screen

- Bond cannot be posted if it has been closed. Bond must be reinstated or entered as a new bond. The posted bond amount cannot exceed the set amount.

## Court Screen

- Criminal cases can now be stayed for interlocutory appeal. Enter a court event with the result code of **STY** along with 99 in the charge field. Once the case is returned from Court of Appeals, REOpen the case and proceed as normal. Caseload will count the stay as a disposition and the case will not age until it is reopened

## Disposition Codes

- When a criminal case is stayed due to an interlocutory appeal, the result code that should be entered on the court screen is **STY** along with 99 in the charge field.

## Reports

- The Restitution Report will now include civil cases. This was changed so that when PPO's have restitution assessed to them, it can be tracked on the Restitution

## **Cross Application**

- The PACC file has been updated to include the new SOS offense codes relating to the new traffic legislation effective October 31, 2010. Refer to attachments for further information.
