### MEMORANDUM

RE: Non-Public Status for Deferred Cases – Changes Effective April 1, 2013

This is a follow up to the SCAO - Trial Court Services memorandum dated February 21, 2013, regarding 2012 Public Acts 547-550. Effective April 1, 2013, all deferred cases (**except** those under Veterans Treatment Court and Practicing Under the Influence) are to be placed in Non-Public status at the time of deferral and will stay Non-Public if the deferral is completed successfully. **This includes all cases currently in deferred status as of April 1, 2013.**

JIS has developed a report from the Traffic/Criminal Report Generator to assist courts in identifying the cases that need to be changed to Non-Public status. You will choose Case Selection in the Report Generator Menu.

If your court has any cases using those two deferral codes, you can identify the cases on the report by looking in the DEFERRED column for VETERANS C and DEFER PUI. Cases with these two deferral codes should only be placed in Non-Public status at the time of successful completion.

**NOTE:** The Veterans Treatment Court Deferral Code, DF07, will be added to your system for use on March 20, 2013. A separate memorandum was sent describing this further.
